NOTES

Currently the Head of the Board is the President who is elected biennially by the members. Subject to the members agreeing to change the Articles of Government the post at the next AGM it will become an Independent Chair from that point. The next AGM is on 29th July 2017. The Board of Directors is conducting the appointment process in the belief that the members will agree to the required Article changes. The appointment will only be confirmed when the Articles have been changed.

Definition

An Independent Chair —a person is independent if they are free from any "close connection" to the organisation and if, from the perspective of an objective outsider, they would be viewed as independent. A person may still be deemed to be 'independent' even if they are a member of the organisation and/or play the sport.

Examples of a "close connection" include:

- a) they are or have within the last four years been actively involved in the organisation's affairs, e.g. as a representative of a specific interest group within the organisation such as a sporting discipline, a region or a home country;
- b) they are or have within the last four years been an employee of the organisation; or
- c) they have close family ties with any of the organisation's Directors or senior employees.
