

# No deal Brexit guidance for the sport and recreation sector

2<sup>nd</sup> Edition (Updated – 24 September 2019)

As we approach the revised deadline for leaving the European Union (EU) on 31 October 2019, it is possible the UK could leave without a deal covering the terms of withdrawal and likely future relationship – a so-called ‘no deal Brexit’ scenario.

This means the UK would leave without a transition period and EU law would no longer apply from the point of exit. This would have a significant impact on all aspects of business activity in Britain including the sport and recreation sector.

The government has published guidance – in the form of Technical Notices – and has developed a Brexit readiness checker to try and help individuals and businesses prepare in the event of no deal.

This briefing serves as an index of all guidance relevant to our sector; some of it applies to the whole sector and some is specific to particular sports. You can find the full list of published Technical Notices [here](#) and the government’s business readiness checker is [here](#).

## Travel and borders

### Visiting Europe after Brexit

The European Commission has proposed that UK nationals can visit the EU for 90 days in any 180 days visa-free in the event of a no deal Brexit in Schengen Area Countries.

This should mean that spectators and sportspersons visiting the EU to watch or participate in sport events will be able to do so, as long as they are not participating in paid work. If a UK citizen is undertaking paid work or wishes to study or stay longer than 90 days, they may require a visa based on individual Member States' immigration rules.

In the event of a no deal Brexit, the government is advising that passports should have at least six months to run and be less than 10 years old (even if it has six months or more remaining). If your passport has six months or less to run by 31 October 2019 then the government is advising that you renew before you travel.

### Movement of sporting goods and equipment

In the event of no deal, the UK will be considered a third country for customs purposes in the EU. This means that sports organisations (including clubs) and individual sports people may be required to make import and export declarations when taking their equipment across the UK/EU border.

This guidance for importers and exporters of goods applies to everyone who will be moving objects in and out of the UK to the EU, even if the movement is for non-commercial purposes, or if the movement is temporary.

If your organisation is planning on moving goods, there are several procedures that may be used, depending on which is the most straightforward and applicable to individual circumstances – for example using ATA Carnets or temporary admissions processes. However, you are advised to familiarise yourself with the guidance below.

## **Common Travel Area (CTA) with Ireland**

In the event of a no deal the UK government has indicated that Irish citizens would have the same rights in the UK as they have now (the right to work, the right to benefits and to vote) and that UK citizens in Ireland will continue to have the same reciprocal rights.

The government has committed to, as now, limited border checks on Irish and British citizens, but in the event of a no deal there are no guarantees that this can be fulfilled. If you are moving across the border for events, please take the time to read the guidance below.

## EU citizens in the UK

In the event of a no deal Brexit, the government has advised that the new points-based immigration system will not apply until 1 January 2021. Between an exit on 31 October and 31 December 2020, EU citizens will be able to move to the UK to study, live, work and access benefits as they do now.

The Home Office is opening a new voluntary immigration scheme – the European Temporary Leave to Remain scheme – which will be available to these citizens. It will be a free online process and those who are successful will be granted three years' leave to remain. Those arriving after 31 December 2020 and those in the UK who do not have leave to remain but wish to stay will have to apply through the new immigration system.

## Providing services after Brexit

The UK will no longer operate under European Economic Area (EEA) regulations for the cross-border trade in services if there's a no deal Brexit. This means that the rights and protections provided by the EU Directives and EU Treaty rights of freedom of movement and freedom of establishment will no longer apply to the UK.

Services provided by UK businesses and professionals will be regarded as originating from a 'third country'. This means UK firms and service providers may face additional legal, regulatory and administrative barriers as a result. Arrangements for short term business travel, recognition of professional qualifications, and the temporary relocation of workers into the EU/EEA will be affected.

## Data

UK organisations that receive personal data from the EU/EEA may not be able legally to continue to do so in a no deal exit, unless they put alternative arrangements in place. You should consult the guidance and review your data arrangements to ensure you can continue to receive and process personal data from the EU/EEA.

Note that UK businesses will still be able legally to send personal data into the EU/EEA.
